As usual applications will only be accepted from CRFC members. An extra condition has now been imposed whereby applicants will also have to provide me with a statement that they have read, and agree to abide by, the terms and conditions under which the RFU allocate tickets to us. It has been necessary to impose this condition because tickets allocated to a CRFC member for one of last year's autumn internationals found their way into the hands of a ticket tout. As a result the Club has had its ticket allocation reduced by 25% for 2009. Fortunately 10% of this has been suspended for two years so it is imperative that we comply with the RFU. Chelmsford RFC is committed to ensuring that members comply with these terms and conditions. Any member not abiding by these will be banned from applying for tickets for a period of two years. A second offence will carry a life ban. Further sanctions, according to section 17 of the Club's constitution, may also be imposed on offending members.
